

TERMS AND CONDITIONS FOR PARTICIPATING IN THE REWARD SCHEME FOR THE NEWLY ISSUED AEGEAN BONUS VISA CARDS

The bank under the name “**ALPHA BANK SOCIETE ANONYME**” (hereinafter referred to as “**Bank**”), as a member of the “**Visa Europe Services Inc.**” (hereinafter referred to as “**Visa**”), in the context of its partnership with the company under the name “**AEGEAN AIRLINES SOCIETE ANONYME**” trading as “**AEGEAN AIRLINES S.A.**”, is offering a reward scheme (hereinafter referred to as “**Reward Scheme**”), for the newly issued Aegean Bonus Visa Debit cards and Aegean Bonus Visa Credit cards, issued by the Bank following an application submitted during the period from 01/07/2026 to 30/09/2026 (hereinafter referred to as “**Card(s)**”) in order to enhance the issuance and use of the aforementioned Cards, under the following terms and conditions for participating in the Reward Scheme.

1. Scope - Reward Scheme Period

1.1. Cardholders who meet the conditions set out in terms 2.1. to 2.3. below, shall be exempt from the annual subscription fee of their Card for one (1) year, in accordance with the detailed provisions of term 3 hereof.

1.2 The Reward Scheme commences on Wednesday, 01/07/2026, at 00:00 a.m. and ends on Monday 30/09/2026, at 11:59 p.m. (hereinafter referred to as “**Reward Period**”).

2. Reward conditions

2.1. Cardholders who have applied for the issuance of one (1) new Card within the Reward Period, using any of the means provided by the Bank (hereinafter referred to as “**Cardholders**”), are automatically entitled to participate in the Reward Scheme.

2.2. Additional necessary conditions for participating in the Reward Scheme are the following:

a) **The Miles+Bonus Account Number of the (principal) Cardholder (FFN) must be correctly stated on the Card application form.** The Cardholder is responsible for declaring the correct FFN number when applying for the Card.

b) The absence of any overdue debts to the Bank on any grounds, on the date of the issuance of the Card.

c) All participants must be aged over eighteen (18).

2.3. Cardholders who apply for the issuance of a new Card during the Reward Period shall not be eligible to participate in the Reward Scheme if an Aegean Bonus Visa card, of the same category as the Card for which the application is submitted, has been cancelled for any reason during the Reward Period or within the twelve (12) months before the commencement of the Reward Period.

3. Reward

3.1. Any Cardholder who meets the conditions for participating in the Reward Scheme shall be exempt from the annual subscription fee of its Card for one (1) year. Following the first year the Cardholders shall be charged the applicable annual subscription fee

which is currently twenty (20) euros for the Aegean Bonus Visa Debit Card and forty (40) euros for the Aegean Bonus Visa Credit Card.

3.2. The reward provided for herein cannot be exchanged for cash or other prizes, is predetermined and binding for the Cardholders, and therefore cannot be modified or changed at the choice of the latter.

3.3. For any further clarification in relation to the conditions and use of the reward by the Cardholders, the latter should contact the Bank via its Customer Service Centre on +30 210 3260000.

4. Personal Data

In the context of processing personal data and provided that a Card issuance application is submitted, the provisions set out in Alpha Bank's "Notice on the Processing of Personal Data" shall apply. The Notice describes in detail how the Bank processes personal data in its capacity as controller and is continuously posted on Alpha Bank's website (<https://apps.alpha.gr/GDPR/files/GDPR.pdf>).

5. Other terms and conditions

5.1. Participation in this Reward Scheme implies unconditional acceptance of all these terms and conditions. The Bank reserves the right to consider a participation invalid if it considers that it conflicts with these terms and conditions for participating.

5.2. The Bank reserves the right to unilaterally amend the terms and conditions of participation in this Reward Scheme and/or the manner in which it is conducted, including the Reward Scheme Period, if deemed necessary and does not assume any liability in relation to any such amendment. Where any such amendment is made in accordance with the aforementioned, it shall be effective from the date on which the amended terms and conditions of participation are posted on the Bank's website (www.alpha.gr/cards).

5.3. Any dispute which may arise regarding the interpretation and/or implementation of the terms and conditions for participating in this Reward Scheme, shall be governed by Greek Law and shall be resolved exclusively by the competent Courts of Athens.

5.4. The present terms and conditions of participation in the Reward Scheme will be posted and always updated during the Reward Scheme Period, on the Bank's special website on the Alpha Bank card portal www.alpha.gr/cards.
